1. **ANNOUNCEMENT:** St. George MCC Inc., hereafter called the "Promoter", will conduct Round 3 Honda RJays Interclub Road Race Series for solo motorcycles at Wakefield Park Raceway Sunday 3rd August 2008.
2. **JURISDICTION:** The above meeting has been authorised by Motorcycling NSW Ltd. (MNSW) who has issued the Motorcycling Australia (MA) Permit No. 08/18059 and is open to holders of current Senior or Junior MA National, Club or One Event Licences.
 - 2.1 Clubs Invited: BEARS, BWP, Far South Coast MCC, MCRC & PCRA.
 - 2.2 The Meeting will be held in accordance with the current Manual of Motorcycle Sport (MoMS), these Supplementary Regulations, the Bylaws of MNSW and any Final Instructions. By entering this meeting all parties agree to comply with these rules, regulations, by-laws and instructions.
3. **ENTRIES:** Entries open forthwith and close at midnight on 25/7/2008.
 - 3.1 For inclusion in printed program, entries need to be received by 22/7/2008.
 - 3.2 In case of postponement/abandonment of the meeting the Promoters may retain all or any part of the entry fee, if such retention is approved by MNSW.
 - 3.3 Only entries received on the official entry form and accompanied by the correct fee will be accepted.
 - 3.4 Late entries will only be accepted at the discretion of the Promoter.
 - 3.5 **TEAMS WITHDRAWING FROM THE MEETING** will have entry fees refunded (less cost of track admission tickets) if entry cancelled by 7pm on the Friday before the event.

7. RB Racing 4 Hour - RACE FORMAT:

- 7.1 The RB Racing 4 Hour will be scored over 1 race and be for a timed period of 4 hours.
- 7.2 The last lap board will be displayed to the leader of the race after the 4 hours has elapsed.
- 7.3 One lap later the leader will be given the chequered flag & the race will be declared.
- 7.4 All riders must enter the pits after receiving the chequered flag.

8. RB Racing 4 Hour - RULES. Each team must start the race with:

- 8.1 A team name or a name will be given to your team by the promoter.
- 8.2 Either 2, 3, or 4 riders.
- 8.3 Minimum of 2 bikes no limit on spare bikes but must fit the entered class and have been scrutineered.
- 8.4 A team manager, who can be a rider.
- 8.5 A rider may transfer from one team to another Team during the event with the written permission of CofC.
- 8.6 Each team must do a minimum of 6 pit stops
- 8.7 Your Grade is the Grade you were as at 1st July, 2008.
- 8.8 Any type of motor cycle (Except Buckets or Historic) can be used as long as it complies with MoMS and no alcohol fuel.
- 8.9 All communications between the Team and Officials must be through the Team manager ONLY.
- 8.10 The winning Team per Class will be the 1st Team to cross the finish line with the highest number of completed laps at the end of 4 hours.

9. RB Racing 4 Hour - Riding time limits for A Grade riders:

- 9.1 No A Grade rider may do any more than 2.5 hours in the 4 hour.

10. Sunday Practice & Qualifying:

- 10.1 There will be 4 practice sessions for the RB Racing 4 Hour.
- 10.2 Only one rider per team may go in each practice session, except with permission from the CofC.

11. GRID POSITIONS:

- 11.1 The 2nd session will be a Qualifying session for Grid positions. So please ensure your qualifying rider goes out in the 2nd session as the rider in this session will determine your grid position.
- 11.2 If a Team does not record a Qualifying time in the 2nd session then they will be allocated a grid at the discretion of the C of C.

12. GROUPS OF MOTORCYCLES(M/C) for Jones XL 1 Hour:

- 1) **Honda 150's**
- 2) **Metrokits**
- 3) **125cc** 125cc GP Bikes or 250cc 4 Strokes

13. CLASSES OF COMPETITION in the Jones XL 1 Hour:

Teams Classes 1, 2, 3 & 4 – Teams with 2 Junior Riders.

Class 1 Only Group 1 motorcycles.

Class 2 Only Group 2 Motorcycles.

Class 3 Mix Group 1 & Group 2.

Class 4 Both Group 3 or 1 Group 3 + Group 1 or 2.

14. JONES XL 1 Hour - RACE FORMAT:

- 14.1 The Jones XL 1 Hour will be scored over 1 race & be for a timed period of 1 hr
- 14.2 The last lap board will be displayed to the leader of the race after the 1 hour has elapsed.
- 14.3 One lap later the leader will be given the chequered flag & the race will be declared.
- 14.4 All riders must enter the pits after receiving the chequered flag.

15. Jones XL 1 Hour - RULES. Each team must start the race with:

- 15.1 A team name or a name will be given to your team by the promoter.
- 15.2 2 riders per Team.
- 15.3 Minimum of 2 bikes no limit on spare bikes but must fit the entered class and have been scrutineered.
- 15.4 A team manager, who can be a rider.
- 15.5 A rider may transfer from one team to another Team during the event with the written permission of CofC.
- 15.6 Each team must do a minimum of 3 pit stops.
- 15.7 All communications between the Team and Officials must be through the Team manager ONLY.

- 15.8 The winning Team per Class will be the 1st Team to cross the finish line with the highest number of completed laps at the end of 1 hours.

16. Sunday Practice & Qualifying:

- 16.1 There will be 1 combine practice & qualifying sessions for the Jones XL 1 Hr.
- 16.2 Both riders from each team will go in this practice session.

17. GRID POSITIONS:

- 17.1 The Grid positions will be determined by the fastest time from each Team during the Practice/Qualifying session.
- 17.2 If a Team does not record a Qualifying time then they will be allocated a grid at the discretion of the C of C.

18. STARTS:

- 18.1 RB Racing 4 Hour & Jones XL 1 Hour Relay races will be Le Mans start.

- 18.2 Racing will commence when the red light is extinguished.

19. If a Motor Cycle breaks down the Rider with the Arm Band:

- 19.1 may make their way back to the pits under direction of an official or be picked up under direction from the CofC.
- 19.2 may take any of the Teams other bikes and continue.
- 19.3 may fix their bike and continue.
- 19.4 may send the next rider out.
- 19.5 If a rider crashes & can make it back to the pits, once the rider is back & the arm band is exchanged the next rider can go out, while the rider that crashed must have themselves and motor cycle checked for safety.

- 19.6 If a rider is hurt and can not return to the pits without assistance, then the Team manager can collect the arm band from the medical centre or under direction from the CofC get the arm band back from the injured Rider once the Arm Band is back at the Pits the next Rider may go out.

- 19.7 If the rider is unable to take part in the remainder of the race the Team can continue less that rider. (NB the retiring rider can be replaced with a rider of the same grade or lower from another team).

- 19.8 Any rider in the Team can use any motor cycle entered by the Team.

- 19.9 No refuelling or repairs are to be carried out in pit lane.

- 19.10 Pits will remain open at all times.

- 19.11 Rider change must be done in pit lane in your assigned bay area.

- 20. **TIMETABLE:** Meeting Starts / Gates Open: 6.50am
Scrutineering: Saturday 2.00 to 4.00pm Sunday 7.00 to 8.00am
Officials Sign-on: 7.45am Riders briefing: 8.00am
Practice: 9.00am Racing: ASAP after Practice ends.

- 21. **ENTRY PASSES:** Each Rider in the Team will receive 3 entry passes. Additional passes can be purchased before the event for \$15ea (Limit 10 per competitor). Anyone over 16yrs without an entry pass will be charged \$20 at the gate.

22. GARAGES:

- 22.1 will be allocated by the Promoter, with one team per garage.
- 22.2 If you wish to be garaged next to another particular Team, please included a note with your entry form detailing which Team & we will do our best to accommodate you.

- 23. **CIRCUIT DESCRIPTION:** The events will be held on the 2.2kms hot mix bitumen circuit at Wakefield Park. The racing direction is clockwise.

24. INSURANCE

- 24.1 National Capital Benefits Scheme, which provides basic cover for death and permanent disability.
- 24.2 Personal Accident & Ambulance insurance is rider's responsibility.

- 25. **MEDICAL SERVICES:** Provided by Ambulance Australia. Being an FIV, Ambulance, 1 Paramedic and 2 Rescue Medical Technicians and will be in attendance from 9am to 5pm on Sunday, 3rd August 2008.

26. AWARDS & PRIZES:

4 HOUR ENDURANCE: Donated by RB Products

1st Overall - \$600 Cash + \$100 Voucher to each team member.

2nd Overall - \$400 Cash + \$100 Voucher to each team member

27 SERIES PRIZES: The 2008 Honda RJays Interclub Road Race Series will award prizes with a total value \$19,266. Details of Series prizes is available on the St George MCC Website.

27.1 Each competitor MUST supply at least ONE OFFICIAL at any one of the rounds & they must be nominated by 7pm Friday before round to be eligible for the Series Prizes. (N.B. You can ride all rounds without supplying an official but you will not be eligible to win series prizes).

27.2 **Points for Officials:** All Sunday officials & Saturday flaggies earn 10 Pts for their rider. Or 5 Pts if assisting with Catering or Scrutineering only.

27.3A maximum of 2 officials per round count towards the Series prizes points score. (More officials are greatly appreciated but no extra points).

27.3 Each Competitor is responsible for their officials sign on before Saturday 8.20am & Sunday 7.45am and Officiate for the whole day to the satisfaction of the Chief Marshal.

27.4 If a competitor changes bikes during the year series points still accrue.

27.5 If a competitor is re-graded during the year the series points still accrue.

27.6 The class points still accrue if the rider remains in the same class.

28 ENTRIES TO CONSTITUTE A CLASS

28.1 Ten entries are required to constitute a class.

28.2 Should there be insufficient entries in any class, the decision to run, cancel, combine or separate classes will be at the discretion of the Promoter.

28.3 The promoter reserves the right of determining eligibility of any machine and to seed combination rider/machine into any event.

29. MACHINES & RIDERS: All motorcycles, equipment & protective clothing must be scrutineered before practice & comply with Current MoMS.

30. RIDING NUMBERS: will be notified with final instructions.

30.1 Each motorcycle within a Team will have the same riding number.

30.2 Riding numbers will be three figures, with the first figure depicting the Class entered.

30.3 Each Team Rider within a Team will be identified by a number on their helmet, being 1 to 4 as per the programme.

30.4 All numbers & plates must comply with MoMs.

31. RIDERS BRIEFING:

31.1 A Rider's briefing will be held prior to the commencements of practice/racing & ALL COMPETITORS & TEAM MANAGERS MUST attend.

31.1 Competitors & Team Managers must Sign On for Riders Briefing to confirm attendance.

31.2 Failure to attend Riders Briefing may result in a penalty up to exclusion from the meeting.

32 EVENT STOPPAGES or RACE FINISHES:

32.1 The chequered flag will signal the end of the race.

32.2 If the event is RED flagged (event stoppage) all competitors must exit the track through the pit entry on the main straight and return to the dummy grid area and wait for further instructions.

32.3 The race will be declared or restarted at the discretion of the C of C.

32.4 If required, time will be allowed for refuelling etc. this will be advised at the dummy grid.

33 DRUG and/or ALCOHOL TESTING: As per MoMS.

34 CODE OF CONDUCT: As per MoMS.

35 RACE FINISHES: will be signalled by a waved chequered flag.

36 NOISE: All machines must comply with the requirements of the track licence being 95dba at 30 metres. You will be given one opportunity to correct the noise problem. A 2nd occurrence will result in exclusion from the meeting.

37 SPECIAL NOTES AND WARNINGS:

37.1 Machine impounding / Examination / Eligibility are at the discretion of the Steward/Clerk of Course.

37.2 Fuel is NOT available at Wakefield Park.

37.3 GARAGES and CARPORTS are available for the use of all competitors.

37.4 No person may wear open footwear in pit lane.

37.5 No non-competitor under 16 years of age may enter Pit Lane.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

- 2. In this declaration:
a) "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
b) "Indemnities" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
c) "MA" means Motorcycling Australia Limited;
d) "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
f) "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

- 3. I ACKNOWLEDGE that:
a) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
i) that I may be injured, physically or mentally, and may be killed;
ii) that my machinery or equipment may be damaged, lost or destroyed;
iii) that competitors may ride dangerously or with a lack of skill;
iv) that track or event conditions may be hazardous and may vary without warning or predictability;
v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
vi) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
vii) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
viii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
b) the Indemnities do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
d) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

4. Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:
- rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnities.

- 5. IN CONSIDERATION of the acceptance of me as a participant in the Meeting:
a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnities and each of them in the following manner:
i) that I participate in the meeting at my sole risk and responsibility;
ii) that I accept the Venue as it stands with all or any defects hidden or exposed;

- iii) that I indemnify and hold harmless the Indemnities, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
b) I AGREE TO RELEASE to the full extent permitted by law the Indemnities and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arises as a result of any act, matter or thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.
6. The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.
7. A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

MEDICAL

8. I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnities will continue to rely upon this declaration as evidence of my fitness and ability to participate.

9. I acknowledge and agree that if required, the Indemnities (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnities and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

PRIVACY

10. I hereby consent to the collection of my personal information by the ST.GEORGE MCC MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by ST. GEORGE MCC. and MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. I understand that I may gain access to my personal information held by ST. GEORGE MCC by contacting ST. GEORGE MCC at PO BOX 124, SUTHERLAND NSW 1499 or MNSW at PO BOX 9172 Harris Park NSW 2150. I understand that if I do not provide the personal information requested above that I may not be permitted to participate in the Event.

PERSONAL HEALTH INFORMATION

11. I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

- a) I ACKNOWLEDGE that:
i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organisers and facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and
iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).
b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:

c) I irrevocably authorise MA and my SCB and hereby appoint MA and my SCB as my lawful attorneys to collect from my Carers, and I hereby direct my Carers to provide to MA or my SCB upon request being made by MA or my SCB, any of my Information including but not limited to any information concerning any incident or event causing or contributing to or resulting from any injury, illness or death to me, the details of any diagnosis and prognosis provided to me by my Carers (or any party with the knowledge of any of my Carers), and any other matter to the knowledge of my Carers that might reasonably be considered to be requested by MA or my SCB for the purpose of improving safety at MA and SCB events.

POLICIES AND REGULATIONS

12. I acknowledge, understand and agree that it is a condition of my participation in the Event that I agree to be bound by, and subject to, the rules, regulations and jurisdiction of MA as amended from time to time. Copies of all MA rules, policies and regulations are available by contacting the MA office.

13. All participants are bound by the MA anti doping policy and thus understand they may be subject to drug testing. Testing conducted by the Australian Sports Anti-Doping Authority (ASADA) is in accordance with the ASADA Act and the National Anti-Doping Scheme. This involves the taking of a sample (any human biological fluid or tissue whether alive or otherwise, or any human breath) for the purpose of detecting the use of a Prohibited Drug or Doping Method. Any participant infringing MA's policy or refusing a drug test may be disqualified or otherwise dealt with in accordance with the terms of the anti-doping policy.
